

### Information about this licence

#### Dictionary

A definition of terms used in the licence can be found in the dictionary at the end of this licence.

#### **Responsibilities of licensee**

Separate to the requirements of this licence, general obligations of licensees are set out in the Protection of the Environment Operations Act 1997 ("the Act") and the Regulations made under the Act. These include obligations to:

- ensure persons associated with you comply with this licence, as set out in section 64 of the Act;
- control the pollution of waters and the pollution of air (see for example sections 120 132 of the Act);
- report incidents causing or threatening material environmental harm to the environment, as set out in Part 5.7 of the Act.

#### Variation of licence conditions

The licence holder can apply to vary the conditions of this licence. An application form for this purpose is available from the EPA.

The EPA may also vary the conditions of the licence at any time by written notice without an application being made.

Where a licence has been granted in relation to development which was assessed under the Environmental Planning and Assessment Act 1979 in accordance with the procedures applying to integrated development, the EPA may not impose conditions which are inconsistent with the development consent conditions until the licence is first reviewed under Part 3.6 of the Act.

#### **Duration of licence**

This licence will remain in force until the licence is surrendered by the licence holder or until it is suspended or revoked by the EPA or the Minister. A licence may only be surrendered with the written approval of the EPA.

#### Licence review

The Act requires that the EPA review your licence at least every 5 years after the issue of the licence, as set out in Part 3.6 and Schedule 5 of the Act. You will receive advance notice of the licence review.

#### Fees and annual return to be sent to the EPA

For each licence fee period you must pay:

- an administrative fee; and
- a load-based fee (if applicable).





The EPA publication "A Guide to Licensing" contains information about how to calculate your licence fees. The licence requires that an Annual Return, comprising a Statement of Compliance and a summary of any monitoring required by the licence (including the recording of complaints), be submitted to the EPA. The Annual Return must be submitted within 60 days after the end of each reporting period. See condition R1 regarding the Annual Return reporting requirements.

Usually the licence fee period is the same as the reporting period.

#### Transfer of licence

The licence holder can apply to transfer the licence to another person. An application form for this purpose is available from the EPA.

#### Public register and access to monitoring data

Part 9.5 of the Act requires the EPA to keep a public register of details and decisions of the EPA in relation to, for example:

- licence applications;
- licence conditions and variations;
- statements of compliance;
- load based licensing information; and
- load reduction agreements.

Under s320 of the Act application can be made to the EPA for access to monitoring data which has been submitted to the EPA by licensees.

#### L4 Hours of operation

- L4.1 Works or activities may only be undertaken at the premises:
  - a. Between 7:00 am and 6:00 pm, Mondays to Fridays;
  - b. Between 7:00 am and 5:00 pm Saturdays; and
  - c. At no time on Sundays or public holidays.

#### L4.2 Ongoing exceptions to approved hours of operation - General

Works and activities are permitted to be undertaken outside of the hours specified in Condition L4.1 for:

i. the delivery of equipment and materials as requested by Police or other authorities for safety reasons;

ii. emergency work to avoid the loss of lives, damage to property and/or to prevent environmental harm;

iii. operation of the enclosures to ensure odour is effectively controlled outside the approved hours of construction, including operation of the ventilation and air emissions control systems;

iv. operation of Water Treatment Plants, including dewatering to prevent flooding, treatment systems and discharge;

v. operation of the air emission control systems to ensure air quality is effectively controlled outside the approved hours of construction; and

vi. works that are inaudible at any residential premises.

vii. traffic and service adjustments where required by the relevant authority and undertaken in accordance with the Construction Noise and Vibration Management Sub-Plan approved under Condition B15 of the consent (SSD 6617).

#### L4.3 Temporary exceptions to approved hours of operation - Construction of Tower Crane

Works and activities are permitted to be undertaken outside of the hours specified in Condition L4.1 for:

a) Works associated with the dismantling of a tower crane at the Crown Sydney Hotel Resort, as detailed in the letter dated 7 September 2018 from Lend Lease titled '*Crown Sydney Hotel Resort - Development Consent SSD 6957 Condition D1 - Out of Hours Work Request - Dismantling TC3*'.

- L4.4 The works approved under condition L4.3 a) must not be undertaken:
  - i. on up to two Sundays between 28 October 2018 and 25 November 2018, inclusive;
  - ii. for dismantling a tower crane at the Crown Sydney Hotel Resort; and
  - iii. between the hours of 9 am and 5 pm.

#### L4.5 Temporary exceptions to approved hours of operation - Perimeter Retention Wall Anchoring

Works and activities are permitted to be undertaken outside of the hours specified in Condition L4.1 for: a) works associated with the anchoring of the approved perimeter retention wall as detailed in the letter dated 12 October 2018 from Lend Lease titled 'One Sydney Harbour - Out of Hours Perimeter Retention Wall (PRW) Anchoring Out of Hours -EPL No 13336 Variation (EPA Ref. DOC18/789982).

L4.6 The works detailed in condition L4.5 a) must be undertaken within the approval interval which is between Monday 29 October 2018 and Friday 30 November 2018 inclusive.

#### L4.7 Notification of works approved outside of standard construction hours

a) The licensee must notify the community likely to be affected by scheduled works approved under condition L4.3 not less than 5 days and not more than 14 days before those works are to be undertaken.

b) The notification must be:

i) by letterbox drop to affected residences and other noise sensitive receivers as well as to other premises likely to be affected by the proposed works; and

ii) detailed on the project website.

c) The notification required by paragraphs (a) and (b) of this condition must:

i) detail the location, nature, scope and duration of the proposed works;

ii) clearly outline the reason that the work is required to be undertaken outside standard construction hours;

iii) detail the expected noise impact of the works on noise sensitive receivers;

iv) clearly state how complaints may be made and additional information obtained; and

v) include the number of the telephone complaints line required by condition M7.1 and the project website address.

#### L5 Potentially offensive odour

Note: Section 129 of the Protection of the Environment Operations Act 1997, provides that the licensee must not cause or permit the emission of any offensive odour from the premises but provides a defence if the emission is identified in the relevant environment protection licence as a potentially offensive odour and the odour was emitted in accordance with the conditions of a licence directed at minimising odour.

L5.1 The licensee must not cause or permit the emission of offensive odour beyond the boundary of the premises.

### 4 Operating Conditions

#### O1 Activities must be carried out in a competent manner

O1.1 Licensed activities must be carried out in a competent manner.

This includes:

a) the processing, handling, movement and storage of materials and substances used to carry out the activity; and

b) the treatment, storage, processing, reprocessing, transport and disposal of waste generated by the activity.

#### O2 Maintenance of plant and equipment

- O2.1 All plant and equipment installed at the premises or used in connection with the licensed activity: a) must be maintained in a proper and efficient condition; and b) must be operated in a proper and efficient manner.
  - b) must be operated in a proper and efficient manner.

#### O3 Dust

O3.1 All activities on the site must be undertaken with the objective of preventing visible emissions of dust beyond the boundary of the premises. Should such visible dust emissions occur at any time, the licensee must identify and implement all practicable dust mitigation measures, including cessation of relevant works, as appropriate, such that emissions of visible dust cease.

#### O4 Waste management

O4.1 The licensee must not cause, permit or allow any waste generated:

a) outside the premises to be received at the premises unless the licensee can demonstrate that the waste meet the classification requirements for Virgin Excavated Natural Material or complies with the requirements of a resource recovery order and resource recovery exemption;

b) on-site to be disposed of outside of the premises except as permitted by c) and d) below.

c) the licensee must assess, classify and manage any waste generated at the premises in accordance with the Waste Classification Guidelines 2014 prior to transporting the waste off site.

d) if waste is transported from the premises, the licensee must ensure that the waste is transported by a waste transporter authorised to transport such waste and is transported to a place that can lawfully accept that waste.

#### O5 Other operating conditions

#### **Bay 3 Spoil Loadout Area**

O5.1 In addition to any other requirements specified in this licence, the following conditions apply to operation of the temporary Bay 1 and Bay 3 loadout areas servicing the Block 4 Odour Control Enclosure (OCE) at the premises:

a) All excavated material to be removed through the Bay 1 or Bay 3 loadout area must be classified and segregated as per the *NSW Waste Classification Guidelines* (EPA, 2014) within the OCE, and prior to loading into trucks.

b) Only excavated material classified as General Solid Waste and/or Asbestos Waste under the *NSW Waste Classification Guidelines* (EPA, 2014) may be loaded through the Bay 1 or Bay 3 loadout areas.

c) The roller doors servicing the temporary Bay 1 or Bay 3 loadout areas must remain closed at all times, unless a truck is being loaded with excavated material at the Bay 1 or Bay 3 loadout areas.

d) No material excavated from within the OCE may be stockpiled outside of the OCE at the temporary Bay 1 or Bay 3 loadout areas.

e) The temporary Bay 1 loadout area is defined in the letter and supporting documentation dated 2 August 2018 from Lend Lease to the EPA (EPA reference DOC18/663364).

e) The temporary Bay 3 loadout area is defined in the letter and supporting documentation dated 13 July 2018 from Lend Lease to the EPA (EPA reference DOC18/502325).

f) With exception of the approved truck loading lock, only one temporary load out bay is to operate at any one time.

### 5 Monitoring and Recording Conditions

#### M1 Monitoring records

- M1.1 The results of any monitoring required to be conducted by this licence or a load calculation protocol must be recorded and retained as set out in this condition.
- M1.2 All records required to be kept by this licence must be:
  - a) in a legible form, or in a form that can readily be reduced to a legible form;

  - c) produced in a legible form to any authorised officer of the EPA who asks to see them.
- M1.3 The following records must be kept in respect of any samples required to be collected for the purposes of this licence:
  - a) the date(s) on which the sample was taken;
  - b) the time(s) at which the sample was collected;
  - c) the point at which the sample was taken; and
  - d) the name of the person who collected the sample.

#### M3 Testing methods - concentration limits

a) any methodology which is required by or under the Act to be used for the testing of the concentration of the pollutant; or

b) if no such requirement is imposed by or under the Act, any methodology which a condition of this licence requires to be used for that testing; or

c) if no such requirement is imposed by or under the Act or by a condition of this licence, any methodology approved in writing by the EPA for the purposes of that testing prior to the testing taking place.

- M3.2 Subject to any express provision to the contrary in this licence, monitoring for the concentration of a pollutant discharged to waters or applied to a utilisation area must be done in accordance with the Approved Methods Publication unless another method has been approved by the EPA in writing before any tests are conducted.
- Note: The *Protection of the Environment Operations (Clean Air) Regulation 2010* requires testing for certain purposes to be conducted in accordance with test methods contained in the publication "Approved Methods for the Sampling and Analysis of Air Pollutants in NSW".

#### M4 Environmental monitoring

M4.1 All noise and vibration monitoring must be done in accordance with the relevent Construction Noise and Vibration Management Plan unless otherwise required in writing by the EPA.

#### M6 Recording of pollution complaints

- M6.1 The licensee must keep a legible record of all complaints made to the licensee or any employee or agent of the licensee in relation to pollution arising from any activity to which this licence applies.
- M6.2 The record must include details of the following:
  - a) the date and time of the complaint;
  - b) the method by which the complaint was made;
  - c) any personal details of the complainant which were provided by the complainant or, if no such details were provided, a note to that effect;

d) the nature of the complaint;

e) the action taken by the licensee in relation to the complaint, including any follow-up contact with the complainant; and

f) if no action was taken by the licensee, the reasons why no action was taken.

- M6.3 The record of a complaint must be kept for at least 4 years after the complaint was made.
- M6.4 The record must be produced to any authorised officer of the EPA who asks to see them.

#### M7 Telephone complaints line

M7.1 The licensee must operate during its operating hours a telephone complaints line for the purpose of receiving any complaints from members of the public in relation to activities conducted at the premises or

by the vehicle or mobile plant, unless otherwise specified in the licence.

#### M9.1 Additional Air Quality Monitoring

a) The licensee must undertake ambient monitoring for fine particulates and volatile organic compounds for the purpose of informing day to day reactive management of air emissions from the premises.

b) The monitoring referred to in a) above must be undertaken in addition to the monitoring required to be undertaken for points 4 and 6.

### 6 Reporting Conditions

#### R1 Annual return documents

R1.1 The licensee must complete and supply to the EPA an Annual Return in the approved form comprising:

- 1. a Statement of Compliance,
- 2. a Monitoring and Complaints Summary,
- 3. a Statement of Compliance Licence Conditions,
- 4. a Statement of Compliance Load based Fee,
- 5. a Statement of Compliance Requirement to Prepare Pollution Incident Response Management Plan,
- 6. a Statement of Compliance Requirement to Publish Pollution Monitoring Data; and
- 7. a Statement of Compliance Environmental Management Systems and Practices.

At the end of each reporting period, the EPA will provide to the licensee a copy of the form that must be completed and returned to the EPA.

- R1.2 An Annual Return must be prepared in respect of each reporting period, except as provided below.
- R1.3 Where this licence is transferred from the licensee to a new licensee:

a) the transferring licensee must prepare an Annual Return for the period commencing on the first day of the reporting period and ending on the date the application for the transfer of the licence to the new licensee is granted; and

b) the new licensee must prepare an Annual Return for the period commencing on the date the application for the transfer of the licence is granted and ending on the last day of the reporting period.

R1.4 Where this licence is surrendered by the licensee or revoked by the EPA or Minister, the licensee must prepare an Annual Return in respect of the period commencing on the first day of the reporting period and ending on:

a) in relation to the surrender of a licence - the date when notice in writing of approval of the surrender is given; or

b) in relation to the revocation of the licence - the date from which notice revoking the licence operates.

- R1.5 The Annual Return for the reporting period must be supplied to the EPA via eConnect *EPA* or by registered post not later than 60 days after the end of each reporting period or in the case of a transferring licence not later than 60 days after the date the transfer was granted (the 'due date').
- R1.6 The licensee must retain a copy of the Annual Return supplied to the EPA for a period of at least 4 years after the Annual Return was due to be supplied to the EPA.

- R1.7 Within the Annual Return, the Statements of Compliance must be certified and the Monitoring and Complaints Summary must be signed by:
  - a) the licence holder; or
  - b) by a person approved in writing by the EPA to sign on behalf of the licence holder.
- Note: The term "reporting period" is defined in the dictionary at the end of this licence. Do not complete the Annual Return until after the end of the reporting period.
- Note: An application to transfer a licence must be made in the approved form for this purpose.

#### R2 Notification of environmental harm

- R2.1 Notifications must be made by telephoning the Environment Line service on 131 555.
- R2.2 The licensee must provide written details of the notification to the EPA within 7 days of the date on which the incident occurred.
- Note: The licensee or its employees must notify all relevant authorities of incidents causing or threatening material harm to the environment immediately after the person becomes aware of the incident in accordance with the requirements of Part 5.7 of the Act.

#### R3 Written report

- R3.1 Where an authorised officer of the EPA suspects on reasonable grounds that:
  - a) where this licence applies to premises, an event has occurred at the premises; or

b) where this licence applies to vehicles or mobile plant, an event has occurred in connection with the carrying out of the activities authorised by this licence,

and the event has caused, is causing or is likely to cause material harm to the environment (whether the harm occurs on or off premises to which the licence applies), the authorised officer may request a written report of the event.

- R3.2 The licensee must make all reasonable inquiries in relation to the event and supply the report to the EPA within such time as may be specified in the request.
- R3.3 The request may require a report which includes any or all of the following information:
  - a) the cause, time and duration of the event;
  - b) the type, volume and concentration of every pollutant discharged as a result of the event;

c) the name, address and business hours telephone number of employees or agents of the licensee, or a specified class of them, who witnessed the event;

d) the name, address and business hours telephone number of every other person (of whom the licensee is aware) who witnessed the event, unless the licensee has been unable to obtain that information after making reasonable effort;

e) action taken by the licensee in relation to the event, including any follow-up contact with any complainants;

f) details of any measure taken or proposed to be taken to prevent or mitigate against a recurrence of such an event; and

g) any other relevant matters.

R3.4 The EPA may make a written request for further details in relation to any of the above matters if it is not satisfied with the report provided by the licensee. The licensee must provide such further details to the EPA within the time specified in the request.

#### R4 Other reporting conditions

#### R4.1 Water Treatment Plant (WTP) Performance Reporting

a) The licensee must submit to the EPA a WTP Performance Report every month, unless otherwise agreed in writing by the EPA.

b) The WTP Performance Report must:

i) review and compare the performance of all WTPs operating on the premises against requirements of this licence, including discharge point concentration limits, discharge volumes and recycled water quantities and quality;

ii) outline any circumstances that triggered additional monitoring;

iii) include details of any incidents and responses;

iv) include the results of visual inspections of water quality controls including silt curtains and any remedial action undertaken to ensure compliance with licence conditions including O1 and O2; and

v) include results of all ambient water quality monitoring, and an interpretation of those results.

#### R4.2 Air Quality Reporting

a) The licensee must submit to the EPA an Air Quality Monitoring Report one month after the first day of operations of the ambient air quality monitoring network and monthly thereafter, unless otherwise agreed in writing by the EPA.

b) The Air Quality Monitoring Report must:

i) review all air monitoring data collected in compliance with the conditions of this licence and any Air Quality & Odour Management Plans;

ii) provide an interpretation of those results; and

iii) detail any relevant site management responses.

### 7 General Conditions

#### G1 Copy of licence kept at the premises or plant

- G1.1 A copy of this licence must be kept at the premises to which the licence applies.
- G1.2 The licence must be produced to any authorised officer of the EPA who asks to see it.
- G1.3 The licence must be available for inspection by any employee or agent of the licensee working at the premises.

#### G2 Signage

G2.1 Each monitoring and discharge point must be clearly marked by a sign that indicates the EPA point identification number.

### 8 Special Conditions

#### E1 Water Treatment Plants

E1.1 WTP Management Plan

a) Prior to the operation of any new Water Treatment Plant (WTP) at the premises the licensee must prepare and provide to the EPA for comment a WTP Management Plan.

- b) The WTP Management Plan must include but not be limited to:
  - i) details of treatment processes and systems; andii) details of the influents likely to be treated in the new WTP.

#### E1.2 WTP Commissioning Report

a) The licensee must submit to the EPA a WTP Commissioning Report within 60 days of the date of commissioning of any WTP

b) The WTP Commissioning Report must include but not be limited to details about plant performance when treating a representative range of influents encountered during the initial stage of the works.

c) The WTP Commissioning Report must be updated as works progress and as other influents are encountered at the site and directed to the WTP for treatment (for example contaminated groundwater, clean storm-water/surface water; contaminated storm-water/surface water; stockpile leachate etc).

d) The WTP Commissioning Report must be provided to an Authorised EPA officer on request.

# E2 Approval of remedial works occuring outside of an Odour Control Enclosure (OCE)

#### E2.1 <u>Remediation Excavation Works Area</u>

a) For the purposes of this condition, 'AQCP' means the document titled 'One Sydney Harbour, Sliver Remediation - Air Quality Control Plan, Revision No. 2', dated 12 September 2017.

b) For the purposes of this licence: the 'Sliver' works area is defined by the boundary depicted in Figure 1 of the AQCP; 'Block 5 NE' is defined by the boundary depicted in Attachment 1 of the document titled 'One Sydney Harbour - Block 5 North - Proposed Minor Remediation without an OCE' (EPA Ref. DOC18/299457).

c) Remediation excavation works within the 'Sliver' works area must be undertaken in accordance with the AQCP.

d) Remediation excavation works within the 'Block 5 NE' works area must be undertaken in accordance with the alternate odour mitigation measures proposed by Lendlease in its letter dated 24 May 2018 (EPA Ref. DOC18/399457) and the additional control measures detailed in the email of 5 July 2018 (EPA Ref.18/399457-04).

e) The licensee must notify the EPA immediately of any exceedance of the Stage 2 or Stage 3 Reactive Trigger values for VOCs (benzene) defined in Table 2 of the AQCP. Notifications must be made by telephoning the Environment Line service on 131 555.

f) Any exceedance of the Stage 2 or Stage 3 Reactive Trigger values for VOCs (benzene) defined in Table 2 of the AQCP within the Sliver works area must be managed in accordance with the 'Three Stage Air Management Procedure', as depicted in Figure 2 of the AQCP.

Note: The conditions of this licence and the Act may include requirements that differ from or are additional to the requirements of the AQCP.

g) Where any inconsistency arises between the requirements of this licence and the Act and the requirements of the AQCP, the licensee must meet the more stringent of the applicable requirements.

h) The licensee must meet all requirements in this licence and the Act that are additional to the requirements of the AQCP.
