## PENALTY NOTICE ADVICE

## Penalty Notice \$15,000 - Breach of Section 64(1) of the *Protection of the Environment Operations Act* 1997

A.J. BUSH & SONS (MANUFACTURES) PTY LTD is the holder of Environment Protection Licence No. 1100 (the licence) issued under the *Protection of the Environment Operations Act 1997* (POEO Act). The Licence authorises the carrying out of livestock processing activities at 1106 Windsor Road, Riverstone NSW (the premises).

#### Background

Condition O5.1 of the licence states:

O5.1 Animal based raw product cannot be stored outside of enclosed structures. Enclosed structures include silos, mixers, sealed buildings, conveyor belts, hoppers and sealed containers.

On the evening of 1 October 2020, the EPA received a number of reports from members of the community alleging offensive odours were being experienced in a new residential subdivision located to the east of the premises. Further reports were received by the EPA on the morning of 2 October 2020.

At approximately 2:35pm on 2 October 2020, two EPA officers entered the premises and attended the Feather Plant. The EPA officers identified that poultry feathers were stored, without cover or containment, on the hardstand in the receival area outside the Feather Plant. The EPA officers identified the poultry feathers as the main source of the odour.

On 7 October 2020, the EPA requested that the licensee provide a written report of the incident under Condition R3 of the licence. A.J. BUSH & SONS (MANUFACTURES) PTY LTD provided this written report on 21 October 2020.

On 24 November 2020, the EPA issued a notice to provide information and/or records (Notice No. 1602438) under s.193 of the POEO Act, to gather further information on the incident. A.J. BUSH & SONS (MANUFACTURES) PTY LTD provided a response to this notice on 8 December 2020.

Through the responses provided by A.J. BUSH & SONS (MANUFACTURES) PTY LTD, it is understood that approximately 15-20 tonnes of poultry feathers were stored on the hardstand outside the Feather Plant at the time of EPA inspection.

On 2 March 2021, the EPA issued a Notice to Show Cause (Notice No. 1606408) to provide A.J. BUSH & SONS (MANUFACTURES) PTY LTD with the opportunity to respond with any reason(s) why the EPA should not take regulatory action in response to the alleged breach of Condition O5.1, namely the storage of animal based raw product outside of an enclosed structure on 2 October 2020. A.J. BUSH & SONS (MANUFACTURES) PTY LTD provided a response to this notice on 17 March 2021.

#### **Regulatory Action**

It is alleged that at approximately 2:35pm on 02-Oct-2020 the following offence was committed:

Contravene condition of licence - Corporation by A.J. BUSH & SONS (MANUFACTURES) PTY LTD at 1106 Windsor Road, Riverstone NSW in contravention of Protection of the Environment Operations Act 1997 - 64(1). The incident involved the storage of raw animal product outside of an enclosed structure in contravention of Condition O5.1, which states:

O5.1 Animal based raw product cannot be stored outside of enclosed structures. Enclosed structures include silos, mixers, sealed buildings, conveyor belts, hoppers and sealed containers.

The EPA has reasonable grounds to believe that A.J. BUSH & SONS (MANUFACTURES) PTY LTD committed an offence under section 64(1) of the POEO Act by contravening licence condition O5.1 on 2 October 2020 by storing animal based raw product outside of an enclosed structure. Further, the EPA believes that there is sufficient evidence to provide the alleged offence.

The EPA has given consideration to this matter and in these circumstances, having regard to the EPA's Compliance Policy and Prosecution Guidelines, the EPA considers it appropriate to issue A.J. BUSH & SONS (MANUFACTURES) PTY LTD with Penalty Notice No. 1608730 (enclosed) for the offence.

Your choices are to;

- a) Pay the amount in full by one of the payment methods listed.
- b) Elect to have the matter dealt with by a court, or
- c) Request a review of the circumstances by providing a written representation.

Your payment, court election or request for review must be received by Revenue NSW to prevent further collection action taking place.

The Fines Act 1996 prevents Revenue NSW from reducing a penalty, or extending the time for payment.
